

## Project Goal

- Problem Statement: Addressing mental and behavioral health is an emergency, and efforts to meet the needs are not keeping pace with demands
- Barriers to mental health care access and connection:



• Goals: Our multi-disciplinary team aims to develop an affordable and effective system of care that helps connect patients and families with unmet mental health needs to services by incorporating dedicated care coordination, electronic enhancements in Epic, and a team approach. Based on data and expert consensus, we will identify gaps and future needs to enhance care.

## Accomplishments

## Identified 2 Primary Care pilot sites, Cobbs Creek and Springfield

- Site champions joined team and helped develop the care model
- Variable staffing with Social Work and Healthy Minds, Healthy Kids

## Hired a Social Work Care Coordinator, Markeena Hunter

## Developed a care model and created IS and Healthy Planet tools

- Partnered with CHQA, IS & Population Health to create a Best Practice Advisory (BPA), SWCC Consult Order, Coordinator Documentation, After Visit Summary (AVS) modifications, Healthy Planet Reports, and a Qliksense Dashboard
- Care model and tools modified along the way based on lessons learned

## Went live with care model on 7/29/20 & expanded to Drexel Hill, Media, and Broomall on 3/10/21

 Expansion to Drexel Hill, Media, and Broomall allowed us to test dedicated master's level Social Work assessment prior to care coordination

## Coordinated efforts with others aimed at improving behavioral health

- Care coordination IS templates & Healthy Planet lists are being created for ED & Inpatient
- SW Behavioral Health Assessment note template is being created for primary care to pilot
- Suicidality AVS is being created

#### **Primary Care Provider – PCP**

Identifies and assesses BH needs, manages, and follows up Consults MSW for additional assessment & level of care

#### Master's level SW(s) - MSW

Helps with BH evaluations & assessments
Confirms or modifies level of care from PCP
Addresses additional needs for all patients at the practice

#### SW Care Coordinator(s) – SWCC

Closes the loop with the PCP

Covers regions, checks in weekly with MSW

#### Healthy Minds, Healthy Kids – HMHK

BH consultation & short-term interventions
Opportunity for SWCC to aid with ongoing needs

## Lessons Learned

- Failed PHQ-9 screens are just the tip of the iceberg when understanding the need
- The pandemic has exacerbated the barriers that existed already, calling for a multifaceted solution
- A team approach is key in managing patients and developing potential solutions
